

# **Monthly Operating Highlights**

# February 2024

HNFHC posted a consolidated income before tax of NT\$2,001mn, after tax of NT\$1,594mn for the month. Accumulated consolidated income before tax was NT\$4,465mn, and after tax was NT\$3,557mn for the month ended February 2024. Year-to-date EPS after tax was NT\$0.26, book value per share was NT\$15.50.

## Earnings breakdown by major subsidiaries:

### > HNCB

HNCB posted a consolidated income before tax of NT\$1,844mn, after tax of NT\$1,469mn for the month. Accumulated consolidated income before tax was NT\$4,121mn and after tax was NT\$3,284mn for the month ended February 2024. Year-to-date EPS after tax was NT\$0.34, book value per share was NT\$23.68.
